**ATTN: All Students****AY 2020 Student Medical Examinations**

Due to the COVID-19 pandemic, the 2020 Student Medical Examinations and New Student Medical Examinations scheduled for April and May, and Specialized Medical Examinations (for those who handle organic solvents and radioactive materials) scheduled for June and July, were postponed. Because the pandemic is still ongoing, we are scheduling the examinations as follows. This schedule may be changed again if the pandemic worsens further. In that event, a notice will be posted on the Student Health Care Center website, so please check this site periodically.

**New Student Medical Examinations**

Dates: October 12 (Mon.), 13 (Tue.), 15 (Thu.), 20 (Tue.), 22 (Thu.), 23 (Fri.); November 9 (Mon.), 10 (Tue.), 11 (Wed.)

Location: Student Health Care Center (Kawauchi Kita Campus)

Eligibility: New students (undergraduate, graduate) entering Tohoku University in AY 2020 who have not yet undergone a medical examination in this academic year are eligible (excludes students who underwent chest x-rays during the June examinations).

Includes new non-degree students (research students etc.) entering the university this academic year. Adult students who underwent a medical exam at their workplace or another off-campus facility may submit a copy of their results to the Student Health Care Center instead of undergoing the university's medical examination. (However, in this case the center will be unable to issue a Medical Examination Certificate.)

**Student Medical Examinations**

Due to the pandemic, examinations will not be conducted in person this year. In place of the medical examination, we ask that you submit the Online Medical Questionnaire below.

**Online Medical Questionnaire**

Online Medical Questionnaire Entry Period: October 5–October 30

Eligibility: All students, except those noted below

These students need not complete the Online Medical Questionnaire:

Students newly entering the university in AY 2020 (undergraduate, graduate), new research students. Adult students who submit a copy of their workplace's medical examination results. Hospital trainees: Graduate School of Medicine, School of Medicine 5th & 6th year; School of Health Sciences, Department of Nursing 3rd & 4th year (midwifery trainees only); Department of Radiological Technology 3rd & 4th year; Department of Medical Laboratory Science 3rd year; Graduate School of Dentistry, School of Dentistry 1st/5th/6th year; Graduate School of Biomedical

Engineering 1st year; Graduate School of Pharmaceutical Sciences 4th year

Details: Details on submitting the questionnaire will be announced later. Students who submit the questionnaire during the designated period will be issued a Medical Examination Certificate on or after Dec 7 2020 in person. Upon coming to receive their certificates, their height/weight will be measured. However, it will show the chest X-ray results from 2019's examination. (If the student did not undergo the chest X-ray in 2019, that part will be left blank.)

### **Specialized Medical Examinations for Students who Handle Radioactive Materials**

Dates: October 26–November 5 (this period may be lengthened as needed after ascertaining the number of examinees)

Details: Students will be notified through their graduate school, faculty, or research institute. The examinations will be held entirely by appointments made online.

### **Specialized Medical Exams for Students who Handle Organic Solvents or Other Specified Chemicals/VDT (Visual Display Terminal) Users**

Due to the pandemic, these examinations will not be conducted as usual this year. Those for whom it is deemed necessary, based on the results of last year's exam, will be contacted individually about testing.

### **Medical Examinations for Hospital Trainees**

These were conducted in June. Students who could not undergo the exam in June should read the notice titled "Notice for eligible students who did not undergo the June medical examination" on the Student Health Care Center website.

Eligibility: Hospital trainees, as described below. Graduate School of Medicine, School of Medicine 5th & 6th year; School of Health Sciences, Department of Nursing 3rd & 4th year; Department of Radiological Technology 3rd & 4th year; Department of Medical Laboratory Science 3rd year; Graduate School of Dentistry, School of Dentistry 5th/6th year; Graduate School of Pharmaceutical Sciences 4th year

### **Issuance of Medical Examination Certificates**

Students who underwent the New Student Medical Examination or Hospital Trainee Examination, or who submitted the Online Medical Questionnaire on time, will be issued Medical Examination Certificates after Dec 7 2020, available for pick-up at the Student Health Care Center only. At the time of issuance height/weight measurements will be performed. Certificates for those who completed the Online Medical Questionnaire will show the chest X-ray results from 2019's examination. (If the student did not undergo the chest X-ray in 2019, that part will be left blank.)
